WHY IS ESG DATA IMPORTANT?

ESG data serves multiple essential purposes and may be relevant for, for example:

- **External reporting:** Ensuring compliance and transparent ESG disclosures to stakeholders.
- **Internal decision-making:** Enabling informed strategic decisions based on sustainability insights.
- **Investor & ESG ratings:** Strengthening investor relations by clearly communicating ESG performance.
- **Supply chain management:** Mitigating ESG risks across suppliers and aligning with sustainability goals.
- **Incentives & remuneration:** Integrating sustainability targets into compensation and incentive programs.
- **Risk management & compliance:** Proactively addressing ESG-related risks and regulatory requirements.
- **Innovation & business improvements:** Leveraging ESG insights to drive innovation, efficiency, and competitive advantage.

WHAT TO CONSIDER WHEN CHOOSING A DATA COLLECTION OR REPORTING SYSTEM

1. PURPOSE & SCOPE

Define your goals: Are you reporting for compliance, stakeholders, or internal improvement?

Ensure the system aligns with industry-specific features and relevant frameworks like GRI, SASB, SDGs, or EU's CSRD.

2. ESG DATA MANAGEMENT & PROCESSING

Choose platforms that process both qualitative and quantitative data with automated collection, validation, and analysis from diverse sources.

3. STREAMLINED REPORTING

Choose software that streamlines reporting and provides best practices while linking ESG data to business outcomes.

4. INTEGRATION WITH EXISTING SYSTEMS

Verify that the system integrates seamlessly with your ERP, HRIS, CRM, and other business systems or data warehouses. Consider availability of pre-built connectors, APIs, and external data source compatibility.

5. SUPPLY CHAIN EMISSIONS

Confirm that the platform can track Scope 1, 2, and 3 emissions, including supply chain impact, to support realistic target-setting and decision-making.

6. CUSTOMIZATION & SCALABILITY

Choose software that fits your current needs while accommodating future growth or complexity.

7. FUNCTIONALITY & INSIGHTS

Assess features like data visualization, benchmarking tools, and actionable insights to proactively improve sustainability performance.

8. EASE OF USE & STAKEHOLDER ENGAGEMENT

Choose user-friendly and intuitive systems that are easy to navigate with role-based access, robust collaboration tools that enable broad adaptation across departments or stakeholders.

9. SUPPORT, SECURITY & COMPLIANCE

Ensure robust data security, adherence to data protection regulations, evolving reporting standards, and strong vendor support—including training, ongoing updates, and technical assistance—to drive adoption.

10. COSTS & VALUE

Evaluate total cost of ownership (TCO), considering licensing fees, implementation, ongoing maintenance, training, and resource requirements against benefits delivered.

WHY INVEST IN ESG DATA AND REPORTING SYSTEMS?

2.Cost Savings: Drives resource efficiency, cutting costs like energy consumption.

THE DIFFERENCE BETWEEN ESG AND SUSTAINABILITY REPORTING

ESG (Environmental, Social, Governance) reporting is investor-oriented. It focuses on measurable data to assess how a company manages risks and opportunities related to environmental, social, and governance factors.

These metrics help investors evaluate financial performance, resilience, and long-term value. Examples include governance practices, diversity metrics, and anti-corruption measures.

Sustainability reporting is stakeholder-focused and provides a broader narrative about a company's impact on environmental, social, and economic systems.

It emphasizes progress toward sustainable development goals and highlights efforts like reducing carbon emissions, conserving resources, and advancing social equity.

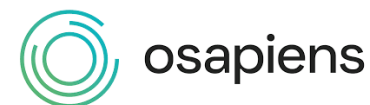

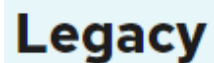
